

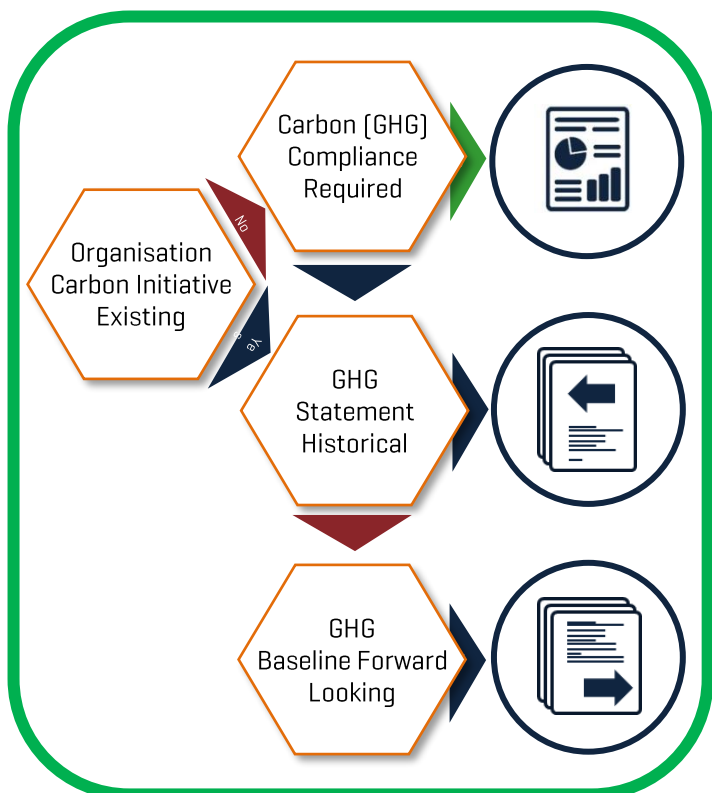

### GHG AGREED ENGAGEMENT – TAILORED SCOPE

For Organisations wanting an independent audit / review, where there is no historical GHG Report or where regulatory compliance is not required. This service is tailored to organisational objectives and goals. Offering a comprehensive report and gap analysis.

### CARBON INVENTORY [GHG] VERIFICATION

Is a historical look back and includes collection and review of historical data and previous GHG Statements. The Audit will independently review and provide a conclusion about the accuracy of the GHG Statement or claim being made. Confirmation of compliance with Audit criteria is also supplied.

### CARBON INVENTORY [GHG] VALIDATION

This service is primarily forward looking and is typically used by Organisations to undertake an Initial GHG Compliance Audit or where significant organisational changes require a review of current and future GHG. Additionally, this service is used to quantify and qualify GHG for specific projects.

### CARBON INVENTORY [GHG] SURVEILLANCE AUDITING

Ongoing monitoring in subsequent years from initial or formal GHG Statement is typically at a lower intensity, this service is offered to Organisations to ensure their GHG reduction pathway stays on track. Surveillance is tailored to an organisation based on risk level and audit objectives.
