1 RESOURCE DEVELOPMENT AND VALUATION

Siecap Advisors completed an opportunity assessment of the gas resources for a client's Queensland coal tenements. Our advisors provided a detailed opportunity assessment which included resource assessment and production forecasting, preliminary field infrastructure design, market research, gas processing, market options, capital and operating cost estimating, risk analysis and ranging, commercial analysis and financial modelling.

2 FEASIBILITY STUDIES | DUE DILIGENCE

Siecap team members conducted due diligence and valuation for an ASX-listed, Papua New Guinea-based company seeking oil and gas reserves to supply power to its portfolio of multi-commodity minerals and power generation projects. The project involved setup and management of a confidential data room, resources and reserve estimation, capital forecast analysis, net present value (NPV) valuation, and commercial and legal due diligence. Red flag reporting was used to provide the client with timely reporting during the exercise.

3 GOVERNANCE, COMPLIANCE AND ASSURANCE

4 BUSINESS IMPROVEMENT AND SUSTAINABILITY

Siecap was commissioned by a power generation company to evaluate future fuelling options for its existing gas-fired power plant. The commission included assessing options to transition the power generator fuel from waste mine gas to coal seam gas. Siecap undertook technical studies and detailed production profiles to develop capital and operating estimates for full economic modelling and industry benchmarking of the alternatives before making strategic recommendations. The client was then able to assess its commercial position and future fuelling options, whilst gaining a detailed understanding of the competitive position of alternative fuels for its power operations.
