① SUPPLY CHAIN AND LOGISTICS STRATEGY



Mercedes-Benz

Driven by the need to support strong sales, Mercedes-Benz Australia engaged Siecap to review their network strategy for spare parts distribution to its multi brand dealer network. Through extensive client engagement and option testing, Siecap devised a strategy that would position the business to continue to provide a premium level of service while cognisant of projected growth, product development and the impact of evolving electric vehicle technology.

② INVENTORY MANAGEMENT



AURIZON

Siecap was to develop an inventory stocking policy for rail assets that would identify and deliver cost savings. This was achieved by developing a segmentation methodology based on business importance, usage value, frequency, item value and supplier lead times; and matching that to an associated inventory management policy. Key recommendations focussed on how to introduce items, their management within the inventory cycle and timely disposal.

③ FACILITY DESIGN



Experiencing substantial growth and the need to evolve its premium delivery model Miele Australia took the decision to undertake a two-year development strategy to develop and commission two new distribution facilities located in Sydney (24,000 sqm) and Brisbane (10,000 sqm). In support of this significant investment Siecap was engaged to test thinking and develop site operational concepts that incorporated leading edge design principles.

④ PROCUREMENT AND CONTRACTING



Thiess is the world's largest mining services provider and to support a change in business structure Siecap was engaged to support in the development and execution of the Procurement Policy, Procedure Application Guidelines and overall procurement process work flow. This included the development of the policy documentation requirements and the roll out of several hundred sourcing initiatives and associated contracts to implement the new policy agreement across all categories.
